#### Sample comment letter - Lake Pillsbury communities:

I strongly oppose PG&E's proposed action to dismantle Scott Dam and drain Lake Pillsbury because it will directly threaten the health and safety of the Lake Pillsbury communities and other communities within the region who depend upon this secure, year-round water source for their families, farms and fire protection.

As a Lake Pillsbury property owner and long time recreational user, I have witnessed first hand how important Lake Pillsbury is for rapid fire fighting response — especially as rivers and streams above Scott Dam dry up seasonally during peak fire season. Without the lake, property and lives will be lost.

The threat of decommissioning has decreased my property value and PG&E's decision to reduce Pillsbury water storage by 25% has impacted area water supply, water quality, and rendered most marinas and docks unusable by mid-July.

PG&E's proposed action risks thriving habitats - bald eagles, tule elk, Western pond turtles, migrating waterfowl - on the *hope* that reopening 35-45 river and stream miles above Scott Dam will revive the entire Eel River fishery. Furthermore, massive amounts of sediment will be released with unpredictable consequences.

PG&E's Surrender Application fails to demonstrate that dam removal is the best path forward for the Potter Valley Project, let alone feasible or responsible under state and federal law. It lacks required environmental data, ignores community safety and economic impacts, and provides no mitigation plans for the loss of critical water resources. Not all local governments, local stakeholders and tribes were engaged or supported by PG&E in the development of the decommissioning plan.

I urge the Commission to delay acceptance of PG&E's Surrender Application until a thorough, transparent and fact-driven environmental analysis is completed, all alternatives to dam removal are evaluated, and developed mitigation plans are put forth for public review. Only then will we know the true impacts of removing the Eel River Dams.

PG&E's proposed action to transfer a portion of its Potter Valley Project lands and water diversion facilities to the Eel-Russian Project Authority does not guarantee water diversions to the Russian River will continue, and the absence of a coordinated risk mitigation plan to ensure that new water storage infrastructure is funded and in place before Lake Pillsbury water storage is eliminated is concerning.

PG&E's Surrender Application fails to demonstrate that dam removal is the best path forward for the Potter Valley Project, let alone feasible or responsible under state and federal law. It lacks required environmental data, ignores community safety and economic impacts, and provides no mitigation plans for the loss of critical water resources. Not all local governments, local stakeholders and tribes were engaged or supported by PG&E in the development of the decommissioning plan.
